

## Western Pizza Contest Rules and Regulations

1. Western Pizza Management & Employees (part-time or full-time), or immediate family members residing in the same residence 1 year prior to or during any time of the promotion from June 1st 2012 –October 24th 2012 of theirs may NOT participate in any part of the promotion.
2. One ballot per person without purchase.
